SPC MEETING SUMMARY - 29 MARCH 2018 & 28 JUNE 2018

In addition to the circulated reports, Andrew McIntyre informed the Board the bulk of the discussions at the Source Protection Committee (SPC) meetings have been based on reviewing and approving the Section 36 (approximate five year) work plan.

CVSPA RESOLUTION 1 – RECEIVE AS INFORMATION FINAL TRENT S. 36 WORKPLAN; AUTHORIZE LEAD SPA TO SUBMIT FINAL TRENT S.36 WORKPLAN TO MECP

Andrew McIntyre reviewed the highlights of the workplan with the Board. Andrew informed the Board authorization is needed from all TCC SPAs for the lead Source Protection Authority (Lower Trent) to submit the final workplan to the Ministry of Environment, Conservation and Parks (MECP).

TCC BUISINESS PROCESS FOR S.48 NOTICE

Andrew reviewed the Trent Conservation Coalition (TCC) business process for section 48 notice with the Board. Section 48 notices are a requirement for a complete application for a drinking water works permit, as per a new regulation under the *Safe Drinking Water Act* that became effective 1 July 2018. The purpose of the regulation is to ensure the Source Protection Authority (SPA) is engaged early on in the planning process for any new, or changes to, municipal drinking water systems and that the technical source protection work can be carried out in ample time. This is to ensure that there are no delays related to source water protection requirements in the drinking water system owner's ability to supply water to the public.

CVSPA RESOLUTION 2 – UPDATED AGREEMENT OF SERVICES BETWEEN CVCA AND CVSPA

Andrew explained the updated agreement between Crowe Valley Source Protection Authority (CVSPA) and Crowe Valley Conservation Authority (CVCA) is to allow CVCA staff to provide services, including issuance of S.48 Notices, as required under the Clean Water Act.
